DEO Seibel stated that first census block groups will be used, and closest estimations are used around the state. An exact number will not be used if it is not available.

Chair Coler stated she likes the new work plan, especially with the separation of CSA's and Flood Control Districts.

 Shared Cost Agreement between Marin LAFCo, Tiburon Fire Protection District and the City of Belvedere and issuance of RFP on financial feasibility and impacts of possible annexation of Belvedere into the District

EO Fried Presented on the Staff Report

Chair Coler opened it up to the commission.

Commissioner Murray stated he saw we are the lead agency and inquired if that would change at any point.

EO Fried stated once we receive the report back conversations between the agencies will ensue and discussions of financial responsibilities will begin with Fried leading the process with the two agencies driving the discussion.

Commissioner Murray inquired on financial feasibility and outcomes.

EO Fried stated that is what the consultant will provide, and that the City has no assets and already contracts with Tiburon Fire so in those regards it is different to past consolidations and simpler.

Commissioner Hilliard stated this is a great start and mentioned the contract between Tiburon Fire Protection District Department and Marin County Fire.

Commissioner Chu inquired about any financial ramifications for Marin LAFCo since we are the lead agency.

EO Fried stated that based on the contract there will be no financial ramifications for Marin LAFCo.

Vice-Chair Rodoni inquired if there is reimbursement for staff time.

EO Fried stated no because they are a member agency and a recommendation was made in the MSR to take this type of action, so in that regard, we will not charge.

Chair Coler opened public comment. Seeing no one wish to speak public comment was closed.

EO Fried stated not much research has been done yet but does not see too much opposition.

Commissioner Lucan asked if we would be proactive or reactive.

EO Fried stated based on what gets placed something administrative would be good if not it would be based on jurisdiction or property owners.

Commissioner Lucan stated that if we are proactive to tread lightly with property owners who may not understand what LAFCo is.

EO Fried stated that legislation will come first and the "how to" after.

EO Fried stated that it would be CALAFCo Lobbyists taking the lead.

Any writings or documents pertaining to an open session item provided to a majority of the Commission less than 72 hours prior to a regular meeting shall be made available for public inspection at Marin LAFCo Administrative Office, 1401 Los Gamos Drive, Suite 220, San Rafael, CA 94903, during normal business hours.

Pursuant to GC Section 84308, if you wish to participate in the above proceedings, you or your agent are prohibited from making a campaign contribution of \$250 or more to any Commissioner. This prohibition begins on the date you begin to actively support or oppose an application before LAFCo and continues until 3 months after a final decision is rendered by LAFCo. If you or your agent have made a contribution of \$250 or more to any Commissioner during the 12 months preceding the decision, in the proceeding that Commissioner must disqualify himself or herself from the decision. However, disqualification is not required if the Commissioner returns that campaign contribution within 30 days of learning both about the contribution and the fact that you are a participant in the proceedings. Separately, any person with a disability under the Americans with Disabilities Act (ADA) may receive a copy of the agenda or a copy of all the documents constituting the agenda packet for a meeting upon request. Any person with a disability covered under the ADA may also request a disability-related modification or accommodation, including auxiliary aids or services, in order to participate in a public meeting. Please contact the LAFCo office at least three (3) working days prior to the meeting for any requested arraignments or accommodations.
